MEMBERSHIP CLASSIFICATION

Sponsors engaged in the sale or management of real estate securities may only join as Class A1 or A2:

CLASS A1: Sponsors. Voting Rights: **Eight (8)** votes in the election process.

Membership Fee: \$10,000. Includes five (5) individual members who are employees of the sponsor. An unlimited number of non-voting members can be included in the membership for an additional \$99/individual and are entitled to receive standard REISA communications.

CLASS A2: Sponsors. Voting Rights: Three (3) votes in the election process.

Membership Fee: \$5,000. Includes (3) individual members who are employees of the sponsor. An unlimited number of non-voting members can be included in the membership for an additional \$99/individual and are entitled to receive standard REISA communications.

Broker-Dealers and Registered Investment Advisors may only join as Associate Members:

ASSOCIATE MEMBERS: Broker-Dealers and Registered Investment Advisors (RIA).

Voting Rights: Three (3) votes in the election process.

Membership Fee: \$1,000. Includes three (3) individual members who are home office employees or serve in a decision-making role. Excludes producing reps whose primary business is retail sales to investors. An unlimited number of non-voting members can be included in the membership for an additional \$99/individual and are entitled to receive standard REISA communications.

Affiliated Parties providing professional, consulting or other services to the real estate industry may only join as Affiliate Members:

AFFILIATE COMPANY MEMBERS: Attorneys, QI's, Managing Broker-Dealers, Mortgage Brokers, Lenders, Accountants, Consultants, Appraisal Firms, Real Estate Firms and other Industry Related Parties.

Voting Rights: Three (3) votes in the election process.

Membership Fee: \$2,500. Includes three (3) individual members who are employees, partners or principals of the Affiliate member. An unlimited number of non-voting members can be included in the membership for an additional \$99/individual and are entitled to receive standard REISA communications.

AFFILIATE SINGLE MEMBER: Attorney, Accountant, Consultant, Independent Wholesaler and other Industry Related Parties. Voting Rights: One (1) vote in the election process.

Membership Fee: \$1000. No additional member option available.

Individual Members: Registered Representatives, Investment Advisory Representatives (IAR) and Licensed Real Estate Brokers.

Voting Rights: One (1) vote in the election process.
